Odour fresh is a concentrated deodorant and air conditioner for use where offensive odours are a problem. The product is based on a blend of essential oils, designed to cover and absorb foul odours from a wide variety of sources.

Directions

Toilets – Add a small amount to the cistern. Refuse heaps – Use a 2% solution in water and spray the source area. Waste Bins – Rinse with a 2% solution.

Sewage – Use about 2 parts per million by drip feed. If spraying, use a coarse spray and do not breathe spray mist.
